


Parking Permit Registration Information For Park Place Village Condominium Association

We are pleased to announce that the Board of Directors for your Condominium Association has contracted with Arizona Parking Solutions (APS) to assist with the enforcement of the parking policies within your community. The Board of Directors and Arizona Parking Solutions would like to ensure that your parking needs are met. In order to ensure the best possible service, you are required to register with the interactive on-line store as soon as possible at www.permit-sales.com/aps  you do not have access to a computer, please call (602) 375-9319 Monday through Friday from 8:00 am – 6:00 pm. APS will gladly assist you with the registration process. You will receive confirmation that your registration has been received and your Community Membership Permit will be sent directly to your mailing address within 10 days of the order. Please place the membership permit in the inside, lower left corner of your windshield. The registration cost is \$15.00 for each vehicle. Only (2) two permits per address will be allowed.

WHAT DOES A MEMBERSHIP PERMIT DO FOR YOU, THE HOMEOWNER/RESIDENT?

1. It ensures that APS will attempt to contact you prior to impounding your vehicle.
2. It ensures that vehicles that are in violation of the "Parking Guidelines" will be addressed as outlined below.
3. It allows APS to distinguish resident vehicles from visitor vehicles on the property and thus allowing for adequate parking in the community for your visitors.
4. It enables APS and your Association to contact you should an emergency arise by maintaining a database of resident information.

Vehicles will be given citations (\$25.00 to \$40.00) or immobilized upon each violation. Once a vehicle has been immobilized, a fee of \$90.00 must be paid to Arizona Parking Solutions before the "Boot" will be removed.

Parking Guidelines

- All residents vehicles must have an Arizona Parking Solutions Permit clearly displayed at all times in the lower driver's side windshield.
- Visitors must park in Visitor Parking Only.
- Residents are never allowed to park in Visitor Parking areas.
- Residents are not allowed to park on the streets at any times.
- No parking is allowed in the designated fire lanes.
- No parking is allowed in the Private driveway areas.
- No parking is allowed in front of the centralized refuse area.
- No recreational type vehicles, such as truck, mobile home, bus, travel trailer, tent trailer, trailer, camper shell, detached camper, recreational vehicle, boat, boat trailer, or other similar equipment or vehicle may be parked, maintained, constructed, reconstructed or repaired on any part of the Condominium, except in the attached garage.
- Membership Permits are not transferable to another party.
- Membership Permits are valid only on the vehicle it has been assigned to. It may however be transferred to a new or replacement vehicle with authorization from Arizona Parking Solutions.
- Please promptly report any stolen or lost permits.
- Only Two Membership Permits will be issued per address.

Permits are the property of Arizona Parking Solutions, and will be issued only to Homeowners/Residents.

Vehicles that are in violation of any of these guidelines are subject to being immobilized. The fee for having the "boot" removed will be \$90.00 and must be paid to Arizona Parking Solutions before the "boot" will be removed.
